

The company has direct subsidiaries in Buhar Enerji Yatırım Ticaret ve Sanayi Limited Şirketi, Pars Enerji Yatırım Sanayi ve Ticaret Anonim Şirketi, Dodo Entegre Enerji Anonim Şirketi, Bozkır Enerji Mühendislik İnşaat Taahhüt Tarım ve Ticaret Anonim Şirketi and Dores Enerji Üretim Satış ve Pazarlama Sanayi Ticaret Anonim Şirketi.

The company's total assets shown in its Balance Sheet are at the level of 5.837.000 TL as of the end of 2017.


